Applying for a Countywide Course

How do I book onto a Course?

The easiest way to book a Governor Training Course is to book online at **www.lancashire.gov.uk/lpds** This enables you to book courses in the evening and weekends at a time that is convenient for you.



To search for a course by keyword and/or subject area, please enter GOV in the 'Find a course' blue box. If you know the course code (for example GOV101) you can enter this in the box to direct you to that specific course, but please do not include the suffix.

Alternatively, please select Governor Training from the drop down list in the pink 'Browse subjects' box.



All current courses are listed on this page. The list automatically updates as new courses are added into the programme throughout the academic year.

In the left hand column under location you can select 'online' to filter the courses that are available to be undertaken from home via an online video conferencing platform.



Please select the course you wish to book from the list, click on 'Book it' to commence the application process and you will automatically be taken through to the course summary and booking page.



The application form will request your Lancashire District and School Number. These can be obtained directly from your school and it is worth keeping a note of your District/School Number for future reference.

By selecting this option, the charge for attending the training will be billed directly to your school if your School DOES NOT buy into the Governor Service's Training and Development SLA.

As a result of your feedback, you can now tick to receive an email acceptance or rejection letter direct to your personal email address as well as course correspondence via the Schools' Portal. This email will be sent two to three weeks prior to the course date.

This means that if you tick this box, the system will remember your school and personal details and so for every online booking you make in the future,

you will not need to re-enter your personal details.

If a course is cancelled, you will be given as much notice as possible and offered, where possible, an alternative training session.

Where can I find my Governing **Board's Training Record?**

It is important to remember that the most definitive record of your governors' training should be kept by the Training and Development Governor who should be updated when a governor has attended training.

School Based and Cluster Courses

Many of our courses can be presented by a member of the Tutor Team at your school at a date and time to suit your Governing Board. These Courses can be bespoke to your Governing Board, using your school's own data and reports to focus on key areas or issues that are impacting upon your school.

How do I arrange School Based Training?

It is essential that the Training and Development Governor has selected suitable dates and times to ensure maximum attendance before contacting the Governor Training and Development Team. To deliver effective training, ideally a minimum of 8 governors should be present.

The Governor Training and Development Team should be contacted at least eight weeks prior to the preferred date(s) and time(s) to discuss the school's requirements

What happens next?

Once the date(s) and time(s) have been agreed, the Training and Development Governor and Headteacher will receive written confirmation from the Governor Training and Development Team and will be asked to inform the whole Governing Board of the session. It is essential that the venue has been confirmed, including arrangements for refreshments and/or presenter equipment.

Prior to the course, the Tutor will be in contact with the Training and Development Governor (or nominated governor) to discuss the individual requirements of the Governing Board and finalise arrangements for the event.

How do I arrange Cluster Training?

During the booking process for your course, please inform the Training and Development Team if you are planning to invite the governors from other local schools to the session. This is very important for the planning and the provision of sufficient course materials.

Should any of the schools participating in the cluster training not purchase the Governor Training and Development SLA, a 'pay as you use' charge will be made to that school.

Dependant on the nature of the course, a cluster training session may not be appropriate as you may wish to maintain the confidentiality of your school's data for example. In this instance, consideration of the countywide course programme for governors may be more appropriate.



E-Learning for Governors (NGA Learning Link)

Schools that purchase the Lancashire Governor Training and Development Service Level Agreement (SLA) are entitled to free access to the National Governance Association (NGA) e-learning platform. This is called 'Learning Link'. It provides over 50 interactive and engaging modules for your entire board to use. For schools that do not purchase the Lancashire SLA, the individual annual subscription to the NGA for this service is currently £165.

- To outline governors' responsibilities and what "good governance" means in practice.


Please bring a hard colour copy of your IDSR and school LSIP to the session which is available from your headteacher.

Understanding a school's strengths and weaknesses from its data set is critical to governors working effectively to hold the senior leadership to account. At the same time, data is technical and can be complex for education lay-people to grasp and remember. This course will equip governors with the skills to interrogate and understand the critical aspects of their own school's data.

During the session participants will then have the opportunity to interrogate their own reports, conduct analysis and interpret data and design questions for their own school leaders. Governors will consider exactly what their data means for their own school and what this may mean in terms of school improvement.

This course is ideal for all secondary phase governors who wish to develop a strong understanding of the headline messages of what their school data means.
