3. For consumers, safety is the most important ingredient of their food. Recent crises have undermined public confidence in the capacity of the food industry and of public authorities to ensure that food is safe. The European Commission has identified food safety as one of its top priorities. The <u>White Paper on Food Safety</u> of January 12, 2000 set out the plans for a proactive new food policy: modernising legislation into a coherent and transparent set of rules, reinforcing controls from the farm to the table and increasing the capability of the scientific advice system, so as to guarantee a high level of human health and consumer protection.

The Official Feed and Food Controls (England) Regulations 2009 implements EC Regulation 882/2004 - on official controls performed to ensure the verification of compliance with feed and food law, animal health and animal welfare rules and EC 669/2009 (as amended) by <u>Commission Regulation (EU)</u> <u>1235/2012</u> - regards the increased level of official controls on imports of certain feed and food of non-animal origin.
