8.	What are partner organisations objectives in relation to Target 2 for Year 3 (2005/6) of the PSA?	<ul> <li>Initially planned to invest support in Modern Matrons. However there were a number of changes within the PCT, which meant that this started much later than anticipated. (Two Modern Matrons are now in post.)</li> <li>The PCT invested resource into <ul> <li>mental health awareness,</li> <li>chair based exercise programme,</li> <li>additional allied health professional support,</li> <li>promotion of exercised on prescription programme, support for older people with diabetes</li> </ul> </li> <li>Since then we have responded to the Choice White Paper and plan to use Health Trainers. There is a great deal of consultation with older people including input into the Lancashire strategy, attended by 14 West Lancs older people, development of older person's forum and representation on the newly formed Partnership Board. Additional ways of involving people in planning and developments are currently reviewed for instance Health Ageing events held 2005 and 2006.</li> </ul>
